#### THE RECTOR

Whereas The Statute of the Libera Università Maria Ss. Assunta issued by decree Rector's

Decree No. 2582 of May 12th, 2022, published in the Official Gazette No. 119 of May

23rd, 2022;

Whereas the Libera Università Maria Ss. Assunta regarding the University Regulations,

approved by Rectorial Decree No. 3073 of 17nd July 2024, as amended;

Whereas The General University Regulations issued by Rectorial Decree No. 1717 of 28th

October 2016, as amended and supplemented;

Whereas The University Erasmus Regulations, approved by Rector's Decree No. 1901 of 22nd

March 2018;

**Considering** that this call is subject to the adoption of the ERASMUS+ programme for 2021/2027

as well as the ECHE accreditation for 2021/2027,

## **DECREES**

a selection procedure for the allocation of **8 scholarships** for the participation in the mobility experience funded by the Erasmus+ program - call 2024 (2024-1-IT02-KA131-HED-000211587) "Blended Intensive Program (BIP)" titled "Summer School of Nonviolence and Nonviolent Communication. A Path to Building Peace in Challenging Times" (September 2-12, 2025). The winners will be required to participate in the online course (**September 2-4**) and the in-person module (**September 7-12**) at the Franciscan Monastery of St. Francis of Assisi (Rovinj, Croatia). This participation will entitle them to achieve 3 CFU/ECTS credits, which are recognized in their study plans according to the regulations of each degree program.

## **Article 1\_Admission Requirements**

All students are eligible to participate if they meet the following criteria:

- Enrolled for the 2024/2025 academic year in the following Master's degree programs at the University: LM59; LM91; LM51
- To expect to graduate **no earlier** than October 2025
- To have an English language certificate equivalent to B2 or higher

## **Article 2\_ Selectin criteria**

The ranking will be drawn up based on a maximum score of 30 points, according to the following criteria, which must be provided in the application:

- Number of CFU acquired by the closing date of the call (up to 10 points)
- Weighted average grade recorded by the closing date of the call (up to 10 points)





• It will be a preferential criterion not to have previously participated in other mobility experiences abroad or to have been awarded mobility grants abroad during the academic year 25/26 (up to 10 points).

In the event of a tie in the ranking, the younger student will be selected.

# **Article 3\_ Application**

The application form (Attachment A), drafted on plain paper and signed in original by the candidate, must be submitted via email to <u>a.babarl@lumsa.it</u> no later than June 3<sup>rd</sup>, 2025 at 12:00 pm, with the email subject line: "Application for BIP 2025". Failure to comply will result in exclusion from the selection procedure.

The application (Attachment A) **must be submitted** with the mandatory attachment of the language certificate as per Article 2.

# **Article 4\_Commission**

The Selection Committee, comprising three members (two Professors and one administrative staff member in secretarial functions), will prepare the merit ranking based on the descending order of points awarded to the candidates. ## Article 5\_European Union Scholarship for Students Participating in BIP Mobility

EU funding for Erasmus+ study mobility students is considered a scholarship for the additional expenses associated with studying abroad.

Students participating in a Blended Intensive Programme are eligible for an Erasmus+ scholarship of  $\[mathebox{\ensuremath{\ensuremath{\epsilon}}}$  79 per day for the days of in-person activities at the host university. For example, for 6 days of in-person activities:  $\[mathebox{\ensuremath{\epsilon}}$  79  $\times$  6 days =  $\[mathebox{\ensuremath{\epsilon}}$  474

Students are also allocated an additional two days for travel.
