Call for applications

LUMSA is happy to announce that the university will host, under the ERASMUS+ Program (Key Action 1) for mobility activities – call 2023, *the Blended Intensive Programmes (BIP) "Values in International Law and European Union Law"*.

We will welcome students from various international universities such as the Villanueva University of Madrid, Saarland University and Örebro University.

Brief Description:

The project aims to analyse the evolution of International law and EU law in safeguarding fundamental values such as democracy, the Rule of Law, and human rights. Traditionally rooted in national legal systems, these principles have gained increasing importance at the international level due to the development of international organizations and their activities in these fields.



The course will explore the origins and driving factors behind this trend, identifying the protected values and examining their content in both EU law and international law. Additionally, it will focus on the legal mechanisms and instruments designed to uphold these values, with particular attention to strategies aimed at countering democratic backsliding and the erosion of the Rule of Law in various countries.

1. General Program Highlights:

1.1. ***Online Week:*** from March 10th to 15th, 2025. (Participation is mandatory);

1.2. ***On-Campus Week:*** March 17th to 22nd, 2025;(Campus via F. Parlatore Palermo);

2. Eligibility:

2.1. Students must hold a B2 English certificate (according to CEFR), issued by CLIC or another accredited institution.

2.2. Participants must maintain their student status throughout the entire program, including the completion of the ECTS credit conversion process.

2.3. Students cannot participate in the programme if they are already participating in another Erasmus mobility period, during the course of the online week as well.

3. Application Process:

3.1. The deadline for the application is March 5th, 2025;

3.2. The file for application must be sent to j.morana1@lumsa.it ;

(n.b. the application file must have the form of a simple email with student's general information and the language certificate attached);

3.3. Spaces are limited, LUMSA will select **15 students**, who will then receive the link for the online registration (which is mandatory and due to student);

4. Scholarship:

4.1. Students will ***not*** receive any monetary contribution for the participation, since there is not a mobility period to sustain;

5. Academic Benefits:



5.1. Earn **3 CFU** upon completing the program. Students can use the credits:

- a. for the course of International Law;
- b. for the course of European Union Law;
- c. for an elective subject course;
- d. as 3 extra credits;

5.2. Receive a digital badge certifying your international competencies.

5.3. Build connections with students and lecturers from across Europe.
